

## INFORMATION ON IFA MEMBERSHIP (IFA BRANCH / DIRECT)

### **General**

Membership of our Association is open to individuals and corporations alike. Our Association comprises taxpayers, their advisers, government officials, members of the judiciary and university professors.

### **Membership through IFA Branches**

Since IFA works through its IFA Branches, please contact the relevant IFA Branch for further details on membership and also to apply for membership. You will find relevant contact details of the IFA Branch on our website ([www.ifa.nl](http://www.ifa.nl)). In case no details are available, please contact the IFA General Secretariat (as per contact details mentioned below), which will subsequently put you in contact with the IFA Branch representative.

### **Direct membership**

If you are residing in a jurisdiction where there is as yet no IFA Branch you can apply for direct membership. In that case please fill out the attached application form and send it to the IFA General Secretariat with your payment for the membership fee for the first year and accompanied by a recommendation from two IFA members. If this proves difficult, a detailed Curriculum Vitae (Individual application) or company profile (Corporate application) will suffice. Upon receipt and after approval by our Association's Executive Board you will be registered in our membership list.

### **Benefits**

In addition to the right to register for the IFA Annual Congresses at a reduced rate, IFA members can access the annual publications ('Cahiers de Droit Fiscal International' ) when published on the secured part of the Global IFA website, containing the General Reports on the Main Subjects to be discussed at the IFA Annual Congresses, as well as all the national reports. Corporate members may send two delegates to the IFA Annual Congress. If a company, whether or not forming part of a worldwide organisation, with one or more offices per country, applies for corporate membership, the membership registration is established in the name of that specific office. Corporate members are asked to appoint a maximum of two individuals to represent them in all respects against the Association.

In addition, only IFA members have access to the secured part of the Global IFA website ([www.ifa.nl](http://www.ifa.nl)), which currently contains IFA Annual Congress documents and recordings, research papers, and other documents of interest. Via this section IFA also offers its members free online access to previous versions of the Cahiers de Droit Fiscal International. New Cahiers will be posted on the website as soon as they become available, i.e. annually on June 15. In the months preceding the IFA Annual Congress documents pertaining to the Main Subjects and Seminars of that Congress will be added to this database as well as on the IFA Society App; shortly thereafter reports on the sessions will be also posted.

### **Membership fees Direct IFA members**

The 2025 membership fees for direct members have been fixed by the General Assembly at: Euro 75 for individual members and Euro 200 for corporate members.

### **Duration IFA Membership**

IFA membership is not a matter of renewal each year. Membership will automatically be continued in the next calendar year unless the member has sent a written notice of termination to the Secretary General of IFA (or to the relevant Branch in case of Branch membership) before 15 November of the current year.
